

INFORMATION PURSUANT TO THE LAW NO. 6698 ON THE PROTECTION OF PERSONAL DATA

a. Identity of data controller and (if any) representative :

This information notice is served under the Law No. 6698 on the Protection of Personal Data (“LPPD”) in the capacity of Data Controller to the business partners and costumers of “KURŞUNLAR YAPI MALZ.İNŞ.SAN VE TİC. A.Ş.” and natural or legal persons it maintains contact with in order to fulfill its information obligation.

b. Personal Data to be processed :

by the COMPANY; from parties such as customers, potential customers, supplier officials, supplier employees and visitors; Examples of personal data that may be subject to processing in categories such as identity information, contact information, legal transaction information, customer transaction information, physical location security information and marketing information are as follows:

c. For What purpose personal data will be processed:

Your Collected personal data;

- Execution of business activities
- Execution of communication activities
- Execution of finance and accounting Works
- Execution of goods and services procurement processes
- Execution of goods and services sales periods
- Ensuring physical space security
- Follow-up and execution of legal affairs
- Execution of marketing processes of products and services
- Providing information to authorized persons, institutions and organizations will be processed within the scope of the processing conditions and purposes specified in Articles 5 and 6 of the Law No. 6698, and will be retained for the maximum period of time and statutory limitation periods specified in the relevant legislation or required for the purpose.

d. To whom and for which purposes the processed personal data may be transferred;

Your collected personal data; It can be transferred to legally authorized public institutions and organizations, administrative authorities and legal authorities, limited to the realization of the above-mentioned purposes.

e. Method and legal basis for collecting personal data

Your personal data are obtained in all kinds of verbal, written or electronic environment for the purposes set forth above in order to offer the products and services we provide as the Company in accordance with the defined legal framework and to allow our Company to fulfill its responsibilities arising under the agreement and the law in this regard in full and correctly. Thus your personal data collected for such purposes may be processed and transferred for the purposes set forth in Articles (1) and (2) of this text in accordance with the purposes and conditions of personal data processing set forth in Articles 5 and 6 of the LPPD.

f. Rights of the Data Subject:

Under the LPPD, as regards your personal data, you are entitled to

- learn whether any personal data is processed;
- if personal data are processed, request information on such processing;
- learn the processing purpose of the personal data and whether such collected data are used for the intended purpose;
- learn the identity of third parties to whom personal data are transferred in or out of the country;
- request correction of any personal data which is processed incompletely or inaccurately;
- if grounds requiring the processing of your personal data cease to exist, request their deletion or destruction;
- request your corrected or deleted, or (if applicable) transferred data to be notified to third parties to whom personal data are transferred;
- file an objection against an outcome which is against your interest, as a result of analysis of the processed data exclusively with automated systems, and
- claim compensation of any damages you suffer as a result of unlawful processing of the personal data.

In order to exercise your above-mentioned rights, you need to send your written request together with the information identifying your identity and your explanations related to the rights you wish to exercise to the address "Akıncılar Mah. Şehit Pamir Cad. No:16 Karesi / BALIKESİR" in wet signed form or to our registered email address info@elitasya.com bearing secure electronic signature.

In the application you will file for exercising your above-mentioned rights you hold as data subject which will contain your explanations related to the right you want to use, your claim should be clear and understandable, should be related to you personally, or if you are acting on behalf of others, you need to be specifically authorized on the issue and your power should be documented, your application needs to contain identity and address information and you should attach documents proving your identity to your application.

In this connection, applications shall be concluded as soon as possible and within 30 days at the latest. Such applications are free of charge for the moment. However, if the procedure requires an additional cost, the fee specified in the tariff determined by the Personal Data Protection Board may be charged.
